Justification

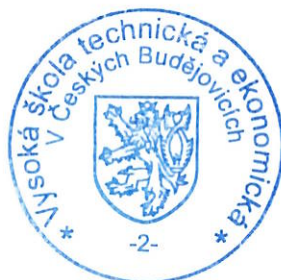
