Justification

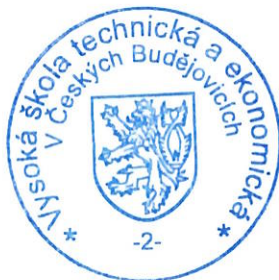
