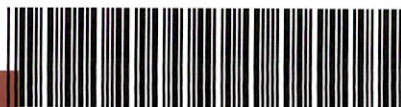

Justification

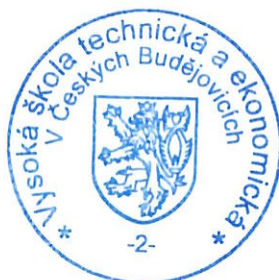
