Justification

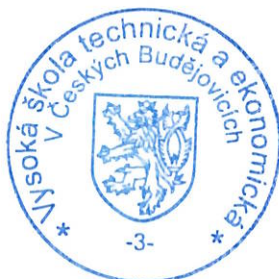
